### Salt Creek Rural Park District Tax Levy for Tax Year 2023 Ordinance 23-05

An Ordinance Levying And Assessing The Taxes Of The Salt Creek Rural Park District For The Fiscal Year Beginning May 1, 2024 And Ending April 30, 2025.

**SECTION I:** That the sum of one million, three hundred forty thousand, twenty-seven dollars (\$1,340,027) be and the same is hereby assessed and levied from and against all taxable property within the limits of said Salt Creek Rural Park District, as the same is assessed and equalized for State and County purposes for the tax year 2023. The said taxes, which are hereby levied, are exclusive of the amounts previously levied for the payment of bonded indebtedness and interest thereon. Said taxes hereby levied being for the fiscal year of said Park District commencing May 1, 2024 and ending April 30, 2025, the various objects, and purposes for which said specified amount hereby levied for each object and purpose is as set forth under the column entitled "levy," as follows:

**SECTION II:** That the Secretary of the Board of Park Commissioners is hereby directed to file with the Cook County Clerk, within the time specified by law, a copy of this Ordinance certified by said Secretary as to its enactment, accompanied by a certificate of the presiding officer as to compliance with the Truth in Taxation Law, and said County Clerk is hereby directed to extend taxes sufficient to produce the amounts levied herein in accordance with applicable law.

**SECTION III**: The unexpended balance of any item or items levied in and by this ordinance may be expended in making up any deficit of any item or items in the same general levy made by this ordinance. The unexpended balance of the tax for general corporate purposes from the preceding year may be accumulated and set aside for the purposes of building repairs and improvements in a capital improvement fund, provided the balance of such fund does not exceed 1.5% of the aggregated assessed valuation of all taxable property within the District.

**SECTION IV:** This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
